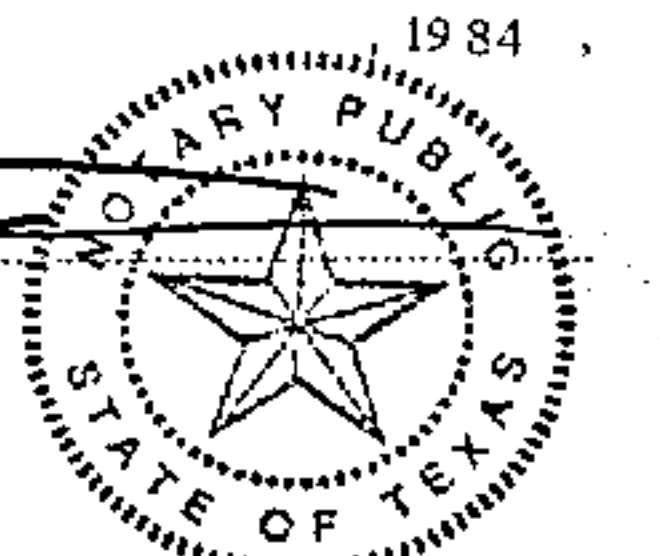

FIELD NOTES

ALL OF THAT CERTAIN PARCEL OR TRACT OF LAND OUT OF THE MALCOLM M. HORNSBY SURVEY NO. 280, WILLIAMSON COUNTY, TEXAS; AND BEING ALL OF A 35.068-ACRE TRACT AS CONVEYED TO ROBERT MITCHELL CLEMENTS AND RICHARD ALBERT NOVOTNY BY CONTRACT OF SALE RECORDED IN VOLUME 488, PAGE 387 OF THE DEED RECORDS OF WILLIAMSON COUNTY; AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a concrete monument found in the curving north right-of-way line of Hazelhurst Drive at the southeast corner of Lot 74 of Northwest Woods, a subdivision as recorded in Book 10, Pages 39 & 46 of the Plat Records of Williamson County, for the southwest corner and POINT OF BEGINNING of the herein described tract;

THENCE, with the east line of said Northwest Woods, N 18°33'38" W a distance of 1055.34 feet to a concrete monument found for an inside corner of this tract;

THENCE, with the north line of said Northwest Woods, the following courses:

S 71°18'30" W a distance of 166.57 feet to an iron pin found in the east right-of-way line of Villa Park Drive at the northwest corner of Lot 86 of said Northwest Woods at an angle point; and

S 71°07'57" W a distance of 227.31 feet to a concrete monument found in the east line of Lot 179 of Forest North Estates, Phase Two, a subdivision as recorded in Book 7, Pages 28 through 31 of the Plat Records of Williamson County, for an outside corner of this tract;

THENCE, with the east line of said Forest North Estates, the following courses:

Along a barbed wire fence, N 19°24'51" W a distance of 223.77 feet to an iron pin set in the east end of Meadowheath Drive at an angle point; and

N 23°23'10" W a distance of 282.08 feet to a concrete monument found at the northeast corner of Lot 282 of said Forest North Estates for the northwest corner of this tract;

THENCE, with the south line of the proposed Mission Bend along a barbed wire fence, the following courses:

N 70°41'38" E a distance of 587.84 feet to an iron pin found at an angle point;

N 72°21'56" E a distance of 664.84 feet to a concrete monument found at the northwest corner of the proposed Springwoods III for the northeast corner of this tract;

THENCE, with the east line of the above described 35.068-acre Clements and Novotny tract and the west line of said proposed Springwoods III, the following courses:

Along a barbed wire fence and extension thereof, S 16°47'07" E a distance of 1689.00 feet to an iron pin set at an angle point; and

S 13°33'04" E a distance of 44.08 feet to an iron pin found at the northeast corner of a 27.36-acre tract as conveyed to Jim E. Moore et ux by deed recorded in Volume 478, Page 632 of the Deed Records of Williamson County for the southeast corner of this tract;

THENCE, with the north line of said 27.36-acre Moore tract along a barbed wire fence, the following courses:

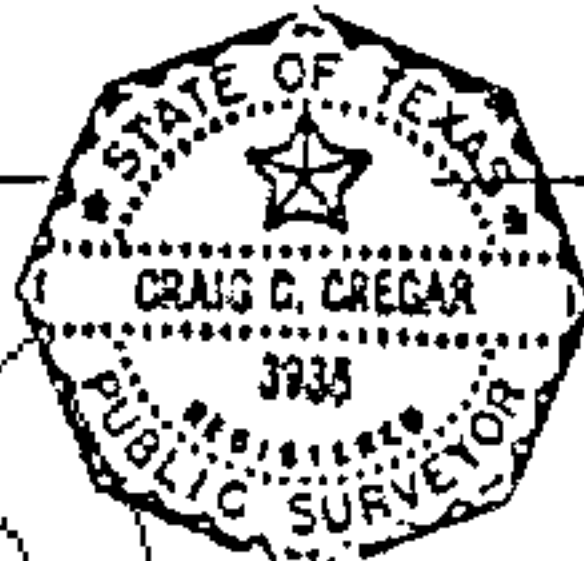
S 83°49'48" W a distance of 30.26 feet to a 60D nail found in a fence post at the northeast corner of the proposed Springwoods IV at an angle point; and

With the north line of the proposed Springwoods IV and extension thereof, S 84°17'22" W a distance of 765.03 feet to the POINT OF BEGINNING, and containing 35.237 acres of land, more or less.
